

The Harbour commercial premises and Dry boat racking facilities are reviewed in an alternate document.

## 1. CAR PARKING PERMIT

Issued from the 1<sup>st</sup> April until the 31<sup>st</sup> March.

Customers can purchase from the mid-January onwards, however not valid until 1<sup>st</sup> April

### Refunds policy:

All pre purchased car park permits cancelled before 31<sup>st</sup> March will be subject to a 10% administration fee.

No refund is available from the 1<sup>st</sup> of April. **(2020/2021 tickets already purchased the refund policy above will be extended to 31<sup>st</sup> May 2020).**

## 2. COMMERCIAL BOAT OPERATORS PERMIT

Available from 1<sup>st</sup> January and valid until the 31<sup>st</sup> Dec

Permanent commercial Harbour mooring holders are required to purchase their commercial licence before the 1<sup>st</sup> February each year.

### Refunds policy:

All commercial boat operators are subject to this licence and are required to pay the full cost Irrespective of when the licence is purchased.

No discount on relinquishing commercial licence is available.

## 3. SLIPWAY PERMIT

Available from 1<sup>st</sup> January and valid until the 31<sup>st</sup> Dec

### Refunds policy:

No discount on relinquishing slipway permit is available.

## 4. TRAILER BOAT PARK STORAGE

Available from 1<sup>st</sup> May valid until 1<sup>st</sup> Oct

### Refunds policy:

Any reserved or prepaid trailer storage fee cancelled prior to the 1<sup>st</sup> May will be subject to a 10% administration fee.

Any trailer storage cancelled by the 31<sup>st</sup> May will be eligible for a 50% refund

No refund is available on relinquished trailer storage from the 1<sup>st</sup> June.

The Harbour reserves the right to reallocate relinquished trailer boat park storage.

## 5. MOORING FEES

All annual Harbour Moorings are issued from the 1<sup>st</sup> of January until 31<sup>st</sup> Dec.

All moorings not renewed by the 1<sup>st</sup> Feb will be reallocated to the harbours waiting List.

Saundersfoot Harbour in the interest of fairness and clarity to its mooring holder has instigated a level of refund that reflects the seasonal use, ensuring that the harbour can continue to balance its budgets, to provide high quality facilities staffing level, and maintenance program, as well as continue to reinvest into improving the Harbours operation and facilities.

### Refunds policy:

This only applies to mooring holders who permanently relinquish their mooring.

No refund is available for vacated or unused moorings.

Any mooring cancelled by the 31<sup>st</sup> March will be eligible for 90% refund

Any mooring cancelled by the 30<sup>th</sup> April will be eligible for 75% refund

Any Mooring cancelled by the 31<sup>st</sup> May will be eligible for a 50% refund

Any Mooring cancelled from the 1<sup>st</sup> June onwards will not be eligible for any refund

The Harbour reserves the right to reallocate relinquished or unused moorings
